## MEMBERSHIP

Annual membership dues of the South Carolina Employers' Advocacy Association are \$500. In addition, members may opt to package the educational program registrations with their membership dues. This may simplify the approval process by combining dues and registration fees into a single request. Please note all members will have access to the two SCEAA webinars at no additional cost.

**Membership is by company. All employees are considered members.**

- ➔ **Basic Package (\$500)** Provides membership for your organization and all of its employees and includes access to member rate registration at any educational events and includes you in member only communications.
- ➔ **Tier 1 (\$600)** This package includes the benefits of the Basic package above along with three (3) program registrations which may be used by employees or guests of the member company. Value: \$725 – a savings of \$125.
- ➔ **Tier 2 (\$700)** This includes the benefits of the Basic package above and six (6) program registrations for employees or guests. Value: \$950 – a savings of \$250.
- ➔ **Tier 3 (\$900)** This package includes the benefits of the Basic package above along with a total of ten (10) registrations that may be used at any of the Regional Programs. Value: \$1250 – a savings of \$350.

**NOTE:** The registrations included in the above packages can be used by **any employee or guest of your organization**. Member registration fee is \$75. Non-member Regional Program registration is \$150 per person.
